COURSE DESCRIPTION

Ecofeminism focuses on Western tradition’s naturalization of women and feminization of nature, drawing the conclusion that the domination of women and the domination of nature are intimately connected and mutually reinforcing. This hypothesized connection of women and nature oppressions gives rise to a common formative structure of “othering” shared by women, animals, nature, people of color and ethnically colonized groups. The course surveys ecofeminist theories, exploring the links between ecological values, principles, activism, and feminisms. Spiritual, philosophical, and activist perspectives are examined through interdisciplinary lens. Teamwork, eco-activism, and a class project are important components of the course.

Learning Objectives

- A. Identify historical evolution of ecofeminism as a discipline and a social movement
- B. Analyze arguments by key stakeholders (through literature, policy documents, white papers, social movements)
- C. Develop and expand upon critical and innovative solutions in ecology and sustainability
- D. Apply core concepts from ecology, sustainability, and social justice to local community initiatives
